



Sonora Rewards™ Terms and Conditions

PROGRAM OVERVIEW - Under the program Sonora Rewards, Participants earn Points ("Points") when they purchase Ultrasound Probe Repairs from Sonora Medical Systems, Inc. Upon request, Participants can redeem their Points for rewards that may include but are not limited to: (1) Sonora Manufactured Test Equipment or (2) Sonora Ultrasound and MRI Service Training Classes or (3) Sonora Ultrasound Probe Repair. The Program, Points and Rewards are void where restricted or prohibited by law.

1. As provided in these rules ('Rules'), account holders ('You' or 'You') earn One(1) Reward Point in the Sonora Rewards program for every 50 USD in qualifying purchases. Contact Sonora Medical Systems, Inc. for full details.
2. Points have no cash value. Points in this rewards program cannot be exchanged for cash or credit, may not be used with any other offer, promotion or discount, cannot be combined with cash to obtain an Award and cannot be earned from or transferred to any other debit card, account, or rewards program.
3. Your earnings statement will normally include the number of Points earned, subject to adjustment as provided for in these Rules. Point Totals will only be updated once monthly.
4. The Program Administrator shall resolve all questions of what constitutes an eligible transaction. All Rules determinations by the Program Administrator are final. Your use of your account following receipt of these Rules will indicate your agreement to these rules.

A product which is received damaged or defective may be returned to the shipper within (30) days of receipt for replacement. All parts, instructions, warranty cards and original packaging materials must be returned with the products.

Your account must be open and in good standing (i. e. not cancelled or terminated by either party or otherwise not available for your use as a payment method) at the time your order is received for processing. Sonora reserves the right to suspend your participation in the Program until the account is in good standing.
10. This program may be modified, suspended, or cancelled and the redemption value of already accumulated Points may be changed without notice and without restriction or penalty.
